Condamine Restructures Board

Condamine Resources Limited (Condamine, the Company) today announced that it has appointed a new Executive Director, Ms Anna Nahajski-Staples. Further, the Company's previous Managing Director and Mining Engineer, Mr Don Harper, has become a Non-Executive Director.

Since Mr Harper's appointment as Managing Director, Condamine has experienced a number of changes in the strategic direction of the business. One key example is the Company's shift in focus from acquiring a development asset with near-term production potential, to accumulating a portfolio of high-grade, brownfield, exploration assets. Additionally, due to challenging market conditions, the Company decided to suspend its IPO plans in late 2018 to preserve cash and shareholder value.

As a result of these strategic changes, and to aid the transition to a more appropriate board composition for a junior exploration company, Mr Harper has resigned from his role as Managing Director and will remain a Non-Executive Director of the Company.

Appointment of Executive Director

Given Condamine's immediate objective of achieving a public listing and completing a capital raising to fund drilling mid-year, the Board has recognised the need for an Executive with international transaction, capital raising and governance experience to guide the Company through this next critical growth phase.

As such, Ms Anna Nahajski-Staples has been appointed as interim Executive Director with immediate effect. Her role will be to:

- > Clarify and re-focus the key strategies of the Company;
- > Lead and oversee Condamine's transition to a public listing; and
- Identify and recruit an experienced Managing Director. In the event that a Managing Director is appointed, it is intended that Ms Nahajski-Staples will return to her role

as Non-Executive Director, providing further continuity and smooth transition in the leadership and governance of the Company.

Ms Nahajski-Staples said Condamine has come a long way since incorporating in 2017 and took this opportunity to thank co-founding Director Mr Don Harper for his contributions.

"Don has been an integral part of the Condamine's establishment, growth and bright future ahead, " said Ms Nahajski-Staples. "The Board would like to thank Don for his hard work to get the Company to this position of strength and look forward to his continued input as a key technical Non Executive Director."

"With permitting expected to be granted this quarter, Condamine is poised for growth in coming months," she said.

"It will be more important than ever to remain committed to the core values that the Company was founded on based around safety, respect, environment, community, transparency and governance.

"We believe the surge of interest in Australian gold stocks globally can and will extend to New Zealand as a Tier 1 jurisdiction – and we're positioning Condamine to best capitalise on that outcome."

Condamine is currently reviewing various corporate opportunities and will update shareholders as discussions advance, continuing its renewed efforts at improved corporate communications.

Ms Nahajski-Staples will continue to act as Joint Company Secretary, following her appointment in March 2019.
